

LOGO DESIGN COMPETITION

The friends of Morwell National Park (FOMNP) Inc. are currently holding a competition to design a suitable Logo to represent the Friends in an official capacity on letter-heads, windcheaters, badges etc. We would like to draw your attention to the details of the competition to encourage your participation in the competition, and also to pass the details onto others who you know would be interested in participating.

The specifications for the FOMNP Inc Logo are:

- I. Entries should be submitted on white card/paper approx A4. $(297mm \times 210mm)$.
- 2. Minimum size 57mm (2¼") suitable for a metal badge. Maximum size - 200mm (8") suitable for a windcheater.
- 3. The design should include the Sarcochilus australis (Butterfly or Gunn's) orchid. (See cover of "Shire of Mornell Community Information, 1987")
- 4. Any other details are at the liberty of the entrants.

Further competition details are as follows:

- I. Competition is open to any person to enter, except for members of FOMNP Inc. and their immediate family.
- 2. Competition closes with the last mail on Friday 2nd September, 1988.
- 3. All entries should be sent to the Secretary/Public Officer of the FOMNP Inc at the address above, together with Name, Address and Phone Number of the designer of the logo enclosed.
- 4. Logo design's will be judged on their suitability by the specifications given above, as well as by their artistic presentation of a logo suitable for a conservation-minded group such as the Friends. The Executive Committee of the FOMNPInc. will initially decide the best six entries, which will then be passed to a panel of local artists to select the two winning designs.
- 5. First Prize is \$70, with second prize of \$30.
- 6. Winners will be notified personally and then in the local press on or before Friday 7th October, 1988.
- 7. FOMNPInc. reserve the right to modify the winning entry if necessary to ensure suitability for graphic reproduction in various forms.
- 8. The judges decision is final and no correspondence will be entered into.

We look forward to receiving your entry in this important competition, and would encourage your support in further advertising it to other interested persons.

Dear Ms Kirner

I am writing to you to inform you of the progress of the Friends of Morwell National Park Incorporated in organising the Fund Raising Appeal for the development of the Billy's Creek extension to Morwell National Park.

The Friends group have formed a steering committee with the objective of selecting members of the community who would be suitable and willing to form the Fund Raising Appeal Committee. We are aiming to select people from the Latrobe Valley with the following attributes:-

- *respected and well known in the community
- *sympathetic towards the philosophy of conservation and National Parks
- . *enthusiastic toward the Billy's Creek Fund Raising Appeal

At this stage we believe we have a couple of very suitable people interested in becoming members of the Fund Raising Appeal Committee. As soon as we have found another 2 or 3 members a public meeting will be called and a committee elected. It is then planned that the committee will run for 12 months and raise \$250,000 in either cash or "kind".

I have enclosed a copy of a booklet that was produced by your Regional staff with assistance from the Friends group. The booklet is not intended to be a public document, it has been produced for use by members of the Friends Steering Committee to explain and illustrate to possible members of the Fund Raising Appeal Committee the potential of Billy's Creek as a recreation area. We felt that this kind of document was essential to "sell" the Appeal to potential Committee members.

The Friends group have accepted the daunting challenge of setting up an Appeal Committee to raise S250,000 for the development of the Billy's Creek extension. However, we believe that the success of the project could be assisted in 2 ways.

Firstly it is essential that a Management Plan be developed for Morwell National Park. The advantages of the Management Plan. running simultaneously with the Fund Raising Appeal are:-

*the Management Plan would assist in providing a framework for the design of plans and drawings of likely recreation developments in Billy's Creek. These could be used by the Appeal Committee during public displays.

- *to gain the maximum amount of support it will be essential to have a Management Plan in preparation. The Appeal and subsequent development of Billy's Creek must be carried out in a professional manner.
- *after completion of the Fund Raising Appeal, if the Management Plan is finalised, development could commence immediately. Donors may be discouraged if a long delay in development is probable.
- *an early decision on the Management Plan will encourage the Fund Raising Appeal Committee and confirm CF&L's support towards the Appeal.

The urgent requirement for a Management Plan has been pursued with officers from your Department and although they fully agree with the need, unfortunately they do not have the funds or resources within the Region to tackle the Plan at this stage.

Secondly we invisage that the Fund Raising Appeal Committee will operate more effectively with the assistance of a "Project Officer". This person could provide support in the following ways:-

- *administrative and clerical support such as the time consuming tasks of mailing Appeal information and telephone contact with potential donors.
- *visiting companies and organisations who may be willing to donate materials, equipment or other forms of assistance.
- *setting up and manning information displays about the Fund Raising Appeal.

Basically we see a need for a person to do a lot of the "leg work" for the Appeal Committee. The Friends group will of course continue to support the Appeal Committee and will be contributing as much time and effort as possible. Unfortunately the majority of us work and our time available is therefore restricted. We believe that if a suitable Project Officer could be employed to work 2 or 3 days each week for the 12 months duration of the Appeal then the target of \$250,000 will be attainable.

Your consideration of allocating funds or personnel to the tasks we have described in order to support the Fund Raising Appeal challenge for Morwell National Park would be very much appreciated.
