consider the following proposed change to the current Constitution of the Friends of Morwell National Park.

**Clause 21. sub-clause (3):**

**Reads:**

Each officer of the Friends shall hold office until the annual general meeting next after the date of his/her election but is eligible for re-election.

**Suggested Reading:**

Each officer of the Friends shall hold office until the annual general meeting next after the date of his/her election but is eligible for re-election to the same position for a second term only. and be required to have a two year break from that position after the second term.

**Clause 21, ,(4):**

**Reads:**

In case of casual vacancy in any officer referred to in sub-clause (1), a general meeting may elect one of its members to the vacant office and the member so appointed may continue in office up to and including the conclusion of the annual general meeting next following the date of his/her appointment.

**Suggested Reading:**

In the event of a casual vacancy in any office referred to in sub-clause (1). a general meeting may elect one of its members. subject to sub-clause (3). to the vacant office and the member so appointed, may continue in office up to and including the conclusion of the annual general meeting next following the date of his/her appointment.

**Explanation:**

The aim of this change is to prevent the one person from being locked into the one position of office for a long duration of time. This only really applies to certain officer positions. such as Treasurer. Secretary (Public Officer). and Vice-President (Activities Coordinator). However. to be fair this clause must be applied to all positions.

This clause may also help to revive the positions of office on the committee. as new members may feel less intimidated by what could be seen as a loaded Committee of office at present. It would also allow for a rotation of people through the position of office, thus sharing the work load more evenly.

**Note:**

If this clause goes to the vote. please give it careful consideration. as no person will ever be forced to leave the Committee, however, they will be given the opportunity to rotate through the positions of office and thus share the work load more evenly. The wording is written such that it is the Officer's position that is to be changed only, thus allowing the retiring Officer to be nominated for another office position.
