It was a mutually advantageous visit as Mr MacFarlane was delighted to be able once again to visit an area he had known so well in his younger years.

Yinnar South Country Fair

Seed Propagation

As most of you will be aware, we have been fortunate enough in past years in having seed collected from the Park propagated at Won Wron prison farm at no cost to us. Unfortunately this service has now ceased, so we must consider ways in which we can propagate our own seed. The Committee has therefore submitted a grant funding application for an amount to cover the cost of materials for a propagation shed, to be located next to the Depot near the Ranger's house. Member Anton Wray has expertise in this are and produced a detailed plan which includes an enclosed area for getting the seeds started, a semi shaded area, and an open area for final hardening off. Should this application be successful, we shall have a good quality facility with an automatic sprinkler system, and a. new and exciting project to challenge us. Should the grant not eventuate, we will have to take steps to propagate the seed with simpler facilities, which could be even more of a challenge! The propagation program needs to be off the ground by early spring this year, so watch out for progress on this project.

News from the Ranger

No doubt you will have noticed the excellent write up on the Park by Ken Wilson which appeared in the Latrobe Valley Express a few weeks ago. One of the results of this were well attended spotlight walks which are a regular feature run by Rob during the school holidays. It was also an excellent boost to promoting the Park generally.

Those of you who have tried to access the Park from Braniffs Road will have seen that an entry gate has been installed, replacing the electric fence. This is padlocked for the time being, but a stile will be built shortly to enable foot access.

The following amendments to the constitution of the Friends of Morwell National Park are proposed by Rob De: Souza Daw and will be voted on at a special general meeting at the start of the April outing.

Clause 2	1) Reword the definition of " Park " to read:	
	The Park means Morwell National Park and includes land proposed as additions to that Park	".]
	Reason: The present wording defines The Park by the management responsibilities given to the Rang nd not by the boundaries of Morwell National Park. The present wording is ambiguous as the esponsibilities of the Ranger may change to include work outside the Park, but not the interest of the Friends. This de facto expression of the objects of the Friends was never intended.	
Clause 2	2) Delete - Existing wording	
	In these rules a reference to the secretary of the Friends is a reference:	
	a) where a person holds office under these Rules as secretary of the Friends - to that person;	
and	b) in any other case, to the public officer of the Friends."	
	Reason: This sub-clause is superfluous as Clause 21(1)(d) and Clause 26(2) state that the Secretary ac s the Public Officer .	xts
Clause 5	Reword Clause 5(2) to read:	
	Annual subscriptions shall be determined at an Annual General Meeting for the year ommencing the day after the Annual General Meeting."	
	Reasons: Removes ambiguity, Specifies the period of time which relates to the annual subscription, The proposed Clause ensures members are financial at the Annual General Meeting.	
Clause 9 (4)	Add a new sub-clause (d) and renumber the current sub-clause (d) to become (e).	
	Sub-Clauses (d) and (e) to read:	
	(d) To determine the annual subscription for the immediate following year.	
	e) To consider the statement to be submitted by The Friends in accordance with Section 30 of the Act.")(3)
	Reasons: This statement supplements Clause 5 and formally gives notice that annual subscriptions for ollowing year will be determined. The new Clause formalises the existing practice at the Friends AG	
Clause 11	Delete reference to pre-paid post in giving notice.	
	Amended Clause to read:	
	'The Secretary of The Friends shall, at least 7 calendar days before the date fixed for holding a general meeting cause to be sent to each member a written notice stating the place, date and tim he meeting and the nature of the business to be transacted at the meeting except as under sub- lause 4. ''	
	Reason: This removes the requirement that the notice of any general meeting can only be given by provaid post.	e-

Rob has prepared this proposal at the request of the committee to tidy Up some anomalies in the constitution and the committee has considered them in depth and endorses them in their present form.
